



## **Hall of Fame Selection Criteria**

To be inducted into the PHAA Hall of Fame is the most distinguished honour that can be awarded to a Member.

The selection criteria and the nomination process must therefore reflect the prestige of the Award. The criteria for induction into the Hall of Fame are:

### **Member**

1. Any member considered for induction into the PHAA Hall Of Fame should have, for not less than 15 years –

- Aided, promoted and/ or worked voluntarily for the PHAA, including at State/ and or National Shows.

- Aided, promoted and/ or worked voluntarily for the PHAA at promotional stands.

- Represented the PHAA by competing at, and/ or promoting the Association at multiple large equine events not of PHAA Affiliation.

2. The Board of Directors of the Paint Horse Association of Australia can from time to time, when presented with sufficient verified evidence, allow for lassitude in the induction of members into the Hall of Fame (unexpected death, accident etc)

### **Horse**

Anyone can nominate a horse that they believe is deserving of Hall of Fame Status. Evidence both written and photographic from newspaper/magazine clippings etc, must accompany any nomination.

1. The inductee must be registered with the PHAA
2. The inductee must be deceased or be over 20 years of age and retired from showing.
3. The inductee into the Horse Hall of Fame must have been outstanding for a period of years as a sire, dam, competitor or must have brought exceptional visibility to the PHAA
4. Stallions gelded at a later date are still eligible.
5. Any horse whom through injury is unable to compete, but whose progeny has made a large impact for the Paint Horse Association of Australia may be considered for induction.
6. Any horse inducted into the Hall Of Fame must have aided the promotion of the Paint Horse in his/her area or field of excellence, or have progeny who have promoted Paints in their area or field of excellence.
7. Promotion means horses who have won major events in open company over a reasonable length of time at the: PHAA National Show; or at Open Feature; or at State and National shows (such as National Pleasure Horse Association, National Reining Horse Assn; National Cutting Horse Assn; National Rodeo Finals; Australian Campdrafters Assn; Equestrian Federation of Australia; Pony Club Assn etc.)

## **Nomination Process**

If you wish to nominate a qualified candidate, all applications are to be made on the official Nomination Form below.

Supporting information must be submitted with the Nomination Form.

It is preferred that evidence written, photographic, newspaper/magazine clippings (other than but including the Paint Horse Assn Journal) etc, should accompany any nomination.

The inclusion of personal letters of recommendation from others is helpful but they must be individual letters i.e. not copies of the same letters, signed by different people.

The PHAA will research the latest information regarding breeder, owner and horse records for each horse nominee and may add to the material.

Please keep in mind that horses selected for induction will usually have name recognition and are well known to the membership.

## **Review Process**

Nominations are to be received by the PHAA Office 3 months prior to the PHAA National Show to be considered by the Board of Directors (BOD) at a board meeting prior to the National Show.

Presentation will be made at the Annual Awards Dinner during the National Show.

A limit of 2 members and 2 horses has been set for induction per year.

Successful nominees will be announced at the PHAA Annual Awards Dinner held during the National Show.

If selected for the Hall of Fame the individual, or if a horse, the registered owner of the nominated horse, along with the nominator, will be notified prior to the Annual Awards Dinner.

Nominees will automatically remain under consideration for three consecutive years, if not selected in the initial year.

In addition to the normal nomination process, there are two other means by which an individual can be placed on the Hall of Fame ballot.

1. A list of past individuals who were influential to the growth of the Association will be drawn to ensure that older deserving individuals are not forgotten. The BOD will review the list each year and may select candidates to be placed on the ballot.

2. Each year a list of individuals will be developed from categories of accomplishment and will be reviewed for inclusion on the ballot. Examples of these categories are:

- Notable National Champions and multi-Honour Roll High Point recipients.
- Leading sires and dams of PHAA champions·
- All-time leading point earners
