INSTRUCTIONS

IMPORTANT - we advise you keep a duplicate copy for your records.

- 1. Keep a separate record sheet on each registered stallion used for breeding purposes;
- Report shall be on file in the office of the Paint Horse Association of Australia (PHAA) no later than 1 July of each calendar year. Refer Rule 119:
- 3. Stallion owners should see the registration certificate of each mare bred. This will assist you in the preparation of this report. As from 1st January, 2012 all mares must be upgraded for breeding purposes PRIOR to being bred.
- 4. Be sure the last recorded owner of the mare is the person who contracts the breeding to this stallion;
- 5. Give exact dates bred. If more than one service is given be sure and show the different dates;
- 6. If pasture bred give date the mare was turned into the pasture and the date she was taken out of the pasture;
- 7. Keep a duplicate copy of this report for your files and future use. Send the original to the PHAA;
- 8. Mares on this report, if progeny not registrable with the PHAA must still be listed but no fee is payable.
- 9. The owners or lessees of all registered Paint, AQHA or TB stallions on or before the first day of July of each year shall make a written report on forms furnished by the Association showing all mares bred to said stallion during the previous year. This includes all mares owned by the owner of the stallion as well as outside mares. Only Paint mares need to be reported by owners of AQHA or TB stallions.
- 10. White office copy of Breeding Certificates (Stallion Service Certificates) MUST accompany this report.
