Payment for AmQHA stallions will not be accepted by cheque, bank deposit or credit only.

If any stallion is **leased**, the certificate of recording/registration for the stallion and an official lease form must be forwarded to this office together with the appropriate lease fee and it is essential that the period of the lease be stipulated.

A PHAA Stallion Yearly Breeding Report must be submitted before 1st July each year by the owner or lessee of the stallion each year. All PHAA mares bred to the stallion must be recorded on the report. The PHAA Breeding Report must be returned to the PHAA Office with the Association copies of the Service Certificates and mare insemination certificates along with appropriate fees within the due dates. Penalty fees apply to late lodgment of Reports. Stallions who are bred to Paint Horse mares prior to being listed with the PHAA, will incur a penalty fee which must be paid prior to the registration of progeny.

If an agent will be signing breeding certificates and returns, an Agent's Authority form must be completed and lodged with the PHAA. If listed PHAA stallions are utilising AI for breeding purposes please complete AI enrollment form annually. For rules regarding **Artificial Insemination** and **Embryo Transfer** please refer to the PHAA rule book.
